## Lower Saxony

### Energy, innovation and quality of life

Lower Saxony is one of Germany's most diverse and economically important federal states. It is the second largest federal state in terms of area and ranks fourth in terms of population. With its favorable geographical location in the north of the country, its strong industry, and its diverse landscape, it offers numerous advantages for residents, businesses, and visitors alike.

One of Lower Saxony's outstanding features is its economic strength. The automotive industry in particular plays a central role, led by the Volkswagen Group, which is headquartered in Wolfsburg. The state is also a leader in agriculture and occupies a top position in the use of renewable energies, especially in the areas of wind power and hydrogen. Lower Saxony has the capacity to store hydrogen in salt caverns for the whole of Europe.

The German Offshore Industry Center was founded in Cuxhaven. Since 2006, the state of Lower Saxony, the European Union, and the Cuxhaven Port Development Company have invested more than €250 million in port and land-based infrastructure. By 2018, the offshore industry had invested around €390 million in production facilities. Two additional berths for the offshore sector have just gone into operation. In the wind energy sector, the port of Emden has also established itself as a base port for onshore and offshore business. As Germany's westernmost seaport, Emden offers ideal conditions for the onshore and offshore wind industry, serving primarily as a base and logistics port for the construction and maintenance of wind farms in the North Sea. The port also offers further potential in terms of space for investors.

Industries such as mechanical engineering, aerospace, and logistics are strongly represented in Lower Saxony and provide a stable economic basis. Transport connections are another plus point. With a dense network of highways, railways, and waterways, as well as the deep-water port of JadeWeser-Port in Wilhelmshaven, Lower Saxony is an important logistics location. Its proximity to major cities such as Hamburg and Bremen with their ports, as well as to the Ruhr region, further reinforces this role.

Lower Saxony also impresses in the field of education and research. Universities such as Göttingen, Braunschweig, and Hanover enjoy an excellent reputation. The academic offerings are complemented by renowned research institutions such as the Max Planck Institute and the German Aerospace Center. Close cooperation between science and industry promotes innovation and strengthens the region as a technology hub.

Last but not least, Lower Saxony scores highly for its high quality of life. Its diverse natural landscape – from the North Sea coast to the Lüneburg Heath and the Harz Mountains – offers numerous recreational opportunities. Cities such as Hanover, Oldenburg, Osnabrück, and Braunschweig combine urban life with cultural diversity and historical substance. Over the past 30 years, the population of Lower Saxony has grown by 770,000 and now stands at 8.2 million.

At the same time, the cost of living is moderate compared to other federal states. Overall, Lower Saxony combines economic dynamism, scientific excellence, and a high quality of life—a combination that makes the federal state an attractive place to live, work, and invest.

# 下萨克森州

## 能源、创新与生活品质

下萨克森州是德国最具多样性且经济地位重要的联邦州之一。该州面积位居德国第二，人口规模排名第四。凭借其位于德国北部的优越地理位置、强大的工业实力以及多样的自然景观，为居民、企业和游客提供了诸多优势。

下萨克森州最突出的特点是其强大的经济实力。汽车工业尤为重要，以总部设在沃尔夫斯堡的大众集团为龙头。此外，该州在农业领域也处于领先地位，并在可再生能源利用方面占据重要地位，特别是风能和氢能领域，下萨克森州拥有为整个欧洲储存氢能的盐穴储存能力。

位于库克斯港 (Cuxhaven.) 的德国海上风电工业中心 (German Offshore Industry Center) 便是其中的重点项目。自 2006 年以来，下萨克森州、欧盟以及库克斯港港口发展公司已在港口及陆上基础设施方面投资超 2.5 亿欧元。到 2018 年，海上风电产业在当地的设施方面累计投资约 3.9 亿欧元。最近，又有两个专为海上风电行业打造的新泊位投入运营。在风能领域，埃姆登港已确立其作为德国陆上和海上风电业务基地港的地位。作为德国最西端的港口，埃姆登为陆上和海上风电产业提供了理想条件，主要作为北海风电场建设和维护的基地及物流枢纽。该港口在空间资源方面还为投资者提供了进一步的发展潜力。

机械工程、航空航天和物流等产业在下萨克森州同样占据重要地位，这些产业为当地经济提供了稳定基础。下萨克森州的交通网络是其另一优势，凭借密集的高速公路、铁路和水路网络，以及位于威廉港的威悉港 (JadeWeserPort) 深水港，下萨克森州成为了德国重要的物流枢纽。毗邻汉堡、不来梅等港口城市及鲁尔区，进一步强化了其枢纽地位。

下萨克森州在教育与科研领域同样表现卓越。哥廷根、布伦瑞克和汉诺威等高校享有盛誉。除优质的学术课程外，马克斯·普朗克研究所和德国航空航天中心等知名科研机构更构筑了其完善的科研体系。科学界与产业界的紧密合作推动创新发展，进一步巩固了该地区作为科技中心的地位。

同样重要的是，下萨克森州因其高品质的生活环境而备受赞誉。从北海海岸到吕讷堡荒原再到哈尔茨山脉，其多样的自然景观提供了丰富的休闲娱乐机会。汉诺威、奥尔登堡、奥斯纳布吕克和布伦瑞克等城市将都市生活与文化多样性及历史底蕴完美融合。过去三十年间，下萨克森州人口增长77万，现已达到820万。

与此同时，该州生活成本在德国各联邦州中保持适中水平。总体而言，下萨克森州兼具经济活力、科研实力与高品质生活，这三重优势使其成为宜居、宜业、宜投资的理想之地。
